any gazetted officer in the IIT Kanpur. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.

16. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractor's service.
17. SPECIAL CONDITIONS

1.0 The Contract is for Round the clock operation and maintenance of Sump wells and sewage treatment plants situated at various places in the campus i/c repairing of pumps and motors.

The contract shall be drawn for a period of 12 (Twelve) months. However the Institute reserves the right to terminate and completely extinguish the service contract within this period from the date of commissioning. It will however issue 1 (one) month advance notice in writing of its intention to do so. The Institute reserves the right to appoint another agency for service contract from the date of termination of contract.

2.0 Similarly the contractor shall be at liberty to seek termination of service contract after the expiry of 1 (one) month from the date of commencement of the contract. It will however issue 1 (one) month advance notice in writing of its intention to do so

3.0 The EMD of Rs. 1,21,351.00 (One Lac Twenty One Thousand Three Hundred Fifty One only), in respect of the successful bidder will be converted into Security Deposit and shall be held by the Institute as a part of security deposit. The security deposit shall be refunded after 3 months from the date of completion of services contract, without any interest. In the event of failure to provide satisfactory services as mentioned above, the security deposit shall be absolutely forfeited.

4.0 The contractor shall appoint a supervisor for allocation of duty to the workers and for monitoring the work. He should be an experienced person with full knowledge of operation & maintenance of sump wells and STP's.

5.0 The supervisor appointed by the contractor shall report to the Junior/Assistant Engineer on day-to-day basis to organize the work as per his directions.

6.0 No part of the contract shall in any manner or degree be transferred assigned or sublet by the contractor directly or indirectly to any person or firm. Violation of this condition shall render the contractor liable for panel action including termination of the service contract and forfeiture of security deposit.

7.0 If the contractor does not commence any work in the manner described in the contract document or if at any time in the opinion of the Engineer-in-charge,

i) Fails to carry out the works in conformity with the contract document.

- ii) Substantially suspends the work without authority from the Institute.

- iii) Fails to carryout and execute the works to the satisfaction of the Institute.

- iv) Commits or permits breach of any other kind, or observes or persists in any of the above mentioned breaches of the contract, after notice in writing shall have been given to the contractor by the Institute requiring such breach to be remedied.
- v) If the contractor shall abandon the works.

Then in any such case, the Institute shall have the power to enter upon the premises, take possession thereof, to rescind the contract and to carry on with the works by the contractor's workmen the supervisor, as the Institute in its absolute discretion may think proper, without making any payment to the contractor.

8.0 The sump well premises shall be in possession of the Institute and the contractor and its employees shall be only permitted to enter the premises to operate & maintain the services. Whenever the service contract is terminated or concluded and the Institute decides that the contractor shall not run the services any more, the Institute will be entitled to restrain the contractor and its employees from the entering the sump wells and IIT Campus.

9.0 The contractor shall make its own arrangement for transportation of the staff to and fro to the campus and to the site of work.

10.0 The contractor shall have to work under the overall control and in close liaison with the concerned Junior Engineer/Assistant Engineer of the work.

11.0 If the contractor fails to commence the work on any day due to any reasons whatsoever, a penalty @ one fifteenth of the monthly contract value per day of default shall be deducted from the monthly bill. However if the services are disrupted for two consecutive days, the contract will be rescinded without any notice and the security deposit shall be absolutely forfeited.

The contractor shall make all efforts to ensure the sufficient labour deployment in each shift. If the manpower is found short due to any reason, the contractor shall have to redistribute the work among the reporting staff and continue to maintain the services in normal conditions.

12.0 The contractor shall furnish to the Engineer-In-Charge, bill in respect of the monthly charges for providing services under the contract, in the last week of every month. The Institute shall ensure payments within 10 (Ten) working days from the date of submission of bill. The contractor shall ensure that the

13.0 The JE/AE shall endorse the following certificate on the monthly bills, before recommending it for payment to Engineer-in-charge.

i) "Certified that the services during the period of the bill have been carried out as per the scope of work, terms & condition of the contract and to my entire satisfaction"

14.0 The contractor shall submit the bill along with the proof of having paid due wages to all the workmen engaged on the job during the preceding month. The wages shall be disbursed to the workmen in the presence of the controlling officer or his authorized representative, who will sign the wage register to certify the payment.

15.0 The employees of the contractor shall carry personal identity cards issued by the contractor, while on duty. In addition to this the contractor shall furnish from time to time a complete list of employees, along with passport size photographs and their residential address, to the security officer of the Institute.

16.0 If and whenever any of the contractor's employees shall, in the opinion of the officer-in-charge of the Institute, be guilty of any misconduct or be incompetent or insufficiently qualified or negligent in the performance of their duties or that it is undesirable for administrative reasons for such persons to be employed in the work comprised in the service contract, the contractor if so directed, shall remove such person from employment within a reasonable time. Any persons so removed from the work shall be immediately replaced at the expense of the contractor by a qualified and competent substitute.

17.0 The contractor shall be responsible for the proper behavior of all the staff employed on the work and shall exercise a proper degree of control over them. In particular and without prejudice to the said generality, the contractor shall be bound to prohibit and prevent any employee from trespassing / action in any way detrimental or prejudicial to the interests of the community or of the Institute of all consequent claims or actions for damages or injury whatsoever. The decision of the Institute upon any matter arising under this clause shall be final binding on the contractor.

18.0 Payment, due to the contractor, under contract shall be made by the Institute by account payee cheques under acknowledgement / RTGS to their account directly. The contractor shall present the bill duly pre-receipted on proper revenue stamp. All efforts shall be made by the Institute to make the payment within 10 working days.

In this connection he shall maintain requisite records and comply with all laws / enactment's, rules, regulations and orders applicable to the contractor's employees in general and in particular laws / enactment's, rules & regulations & orders dealing with employment of contract labour, payment of minimum wages, fire & safety regulations, security arrangements and such other rules & regulations as may be applicable at present or made applicable hereafter.

25.0 Drinking liquor within the Institute campus is strictly prohibited. Violation of this rule by the employees of the contractor shall render them liable for prosecution as per law and automatically disqualify them from deployment on the work

26.0 The Institute shall not be liable for any damage or compensation payable in respect of or in consequence of any accident or injury to any person in the employment of the contractor, save and except an accident or injury resulting from any act or default of the Institute. The contractor shall indemnify and keep indemnified the Institute against all such damage and compensation whatsoever in respect of or in relation their to.

27.0 The contractor's staff not be treated as the Institute staff for any purpose whatsoever. The contractor shall be responsible for strict compliance of the

statutory provisions of relevant labour laws applicable from time to time, in carrying out the service contract. The Institute shall not be liable to any penalty for which the contractor is responsible under the law. However if the Institute is forced to pay any cost of any nature on account of contractor's liabilities, the said cost shall be recovered from the payments due to the contractor.

28.0 The contractor shall be responsible for fulfilling the requirement of all statutory provisions of relevant enactment's viz minimum wages Act payment of wages Act, Industrial Dispute Act, Contract Labour (Regulation & Abolition) Act and all other labour & industrial enactment's at their own risk and cost in respect of all staff employed by them. i) The difference in minimum wages applicable to the labour are revised by Govt. of India, subsequent to the date of submission of tender shall be paid by the contractor to the labour and reimbursed by the institute on production of claim. Profit @10% shall be paid on this claim.

ii) The contribution of EPF& ESIC by the contractor shall be reimbursed on production of the receipt of deposit of the same in the office of competent authorities. Administrative expenses deposited by the contractor shall not be reimbursed.

iii) The Contribution of GST shall be paid along the monthly bill.

31. The performance guarantee @5.00% of contract value shall have to be deposited by the contract in the shape of FDR issued by any nationalized Bank at the time of execution of agreement and same shall be released after one month of satisfactory completion of the work.

32. The two sets of worker's uniform as prescribed by the institute shall be provided to all the workers by the Contractor on his own cost.

33. The old/ unserviceable material shall have to be deposited in the office of the AE/JE; the proper records of the same shall have to be maintained by the contractor duly authenticated by the Engineer-In-Charge. The Contractor has

Scope of work:

The contract is for the round the clock operation and maintenance of the sump wells and Sewage treatment plants within the IIT campus premises for 12 months. The security deposit shall be released after 3 months from final bill payment of this work. The EPF and ESI shall be reimbursed on production of the original receipt along with the monthly bills.

1.0 The work includes the following operations:

- i) Operate the sump well and STPs along with motor & pumps & supervise the pumping operations round the clock.
ii) Undertaking electrical & mechanical repairs of pumps, motors, starters and the connecting cables i/c taking out and lowering after servicing.
iii) Protecting the sump wells and STPs against theft and trespass.
iv) Maintaining the pumping stations neat & clean at all times.
v) Maintaining close liaison with the Engineer-In-Charge and the Junior/ Assistant Engineer for receiving instructions and for deploying manpower as per the requirements.
vi) Any other work assigned by the Engineer-In-Charge provided it does not require any additional manpower.
vii) Bleaching powder dosing in the treated water before supply for horticulture purpose. (The bleaching powder of approved brand and manufacturer to be purchased by the contractor for the period of not more than three months at a time. The cost of bleaching powder shall be included in the contract value).
viii) The Contractor shall carry out all facility operation and waste water disposal operations in accordance with Good Operating Practices, as set out in this Contract and CPHEEO manual. The Facility operation and waste water disposal operations shall include, but not be limited to the following:
- Operating sump wells, pumps and sewerage treatment plants to maintain the quality of treated sewage within the prescribed

- The Contractor shall take all necessary measures to minimize the power consumption in carrying out its operations

ix) The Contractor shall carry out preventive, routing maintenance and break down maintenance operations for proper upkeep of plant in accordance with good operating practices. The following items shall be included in such maintenances.

I. Pumping Machinery and Treatment Plant Equipment

- Cleaning of chemical dosing tanks at least twice a year as per approved programs and disposal of silt.
- Repairing of damaged pipes, fittings and valves for suction and delivery pipe.
- Repairing and replacing pump impellers, bearings shafts.
- Repairing of motors and pumps i/c lowering etc. complete to make the plant fully functional.
- Repairing starters, circuit breakers, capacitors.

The Contractor shall operate and maintain the entire Plant within its contract price for a total operation and maintenance period of 365 days from the date of taking over of the plant (or such unit) from the JE/AE. The operation and maintenance period shall include the defect liability period and shall commence from the date of taking over from the JE/ AE. All necessary repairs, maintenance, overhaul, replacements etc., shall be made during the O & M to maintain the Plant at the status of formal handing over after the P.G test. At the end of O & M period the plant shall be handed over to the JE/AE in fully functional condition.

The price for O & M bill shall include supply of all tools, tackles, spares, lubricants, laboratory chemical, glassware and polyelectrolyte etc but excluding the cost of electricity.

b. Downtime:

The Plant shall never be operated at less than 50% of its design capacity due to maintenance and repair reasons. g. Operational services

The Contractor shall operate the complete sewage treatment Plant and associated services on a continuous 24-hour basis.

The Contractor shall operate and utilize the control and monitoring systems provided. If found necessary, he shall make adjustments (within the operation range) of the control system and equipment, so that the Plant operation matches the treatment process requirements.

The Contractor shall provide all consumables and spares required for operating and maintaining the Plant in good condition. The grit, Screenings, Wet sludge and other garbage generated in the plant shall be removed from the site on daily basis. No accumulation of such residues shall be permitted within the Plant campus without express application by Contractor giving adequate reasons as well as permission of Engineer-In-Charge and JE/AE. The Contractor shall such residues in conformity to Environmental regulations/ rules in force. The Engineer-In-Charge and JE/AE may, if required, decide the mode and timing of disposal of such residues in consultation with concerned Environmental and Civic Authorities. Such directions shall be followed by the Contractor promptly, both in letter and spirit, without any reservations and without any increase in O&M /other costs. The loading, unloading and transportation cost of these shall be borne by the Contractor and shall be included in the price quoted by the Contractor for O&M.

The Contractor at his own expense shall provide all tools, cleaning, and housekeeping equipment, security and safety equipment

h. Manpower

The Contractor shall provide experienced supervisors and labors necessary to operate and maintain the treatment Plant and works properly, safely and efficiently on a continuous 24-hour basis for the full term of the O & M period. While doing so due consideration shall be given to the labor laws in force.

The qualification and capability of Contractor’s personnel shall be appropriate for the tasks they are assigned to perform. The staff provided shall be fully trained in the operation of the works before being given responsibility. If, in opinion of the Engineer-In-Charge and JE/AE, a member of Contractor’s staff is considered to be insufficiently skilled or otherwise inappropriate for the assigned task, and Engineer-In-Charge and JE/AE informs the Contractor in writing, the Contractor shall replace him with a person of appropriate skills and experience for the task, approved by the Engineer-In-Charge and JE/AE, within one month of being so informed.

i. Safety

5.0 MAINTENANCE

The Contractor shall ensure the continuity of the Plant operations and the breakdown or the deterioration in performance of the Plant under normal operating conditions of any items of the Plant and equipment and component parts thereof shall be minimized.

The classes of maintenance provided shall comprise full Operational maintenance and standby Maintenance.

Full operational maintenance comprises the planned and regular maintenance carried out by the Contractor on a day-to-day basis, including cleaning, lubricating, minor adjustment, together with the preventive and corrective maintenance plan for those items of the Plant and equipment within the treatment works which have been commissioned and made operational.

Standby maintenance comprises the planned and regular maintenance carried out by the Contractor including cleaning, lubricating, periodic, and minor adjustment of all items of Plant and equipment within the treatment works which have been installed but have not yet been made operational.

The Contractor shall strictly adhere to the manufacturers' recommendations with respect to equipment maintenance, and only use types and grades of lubricants to be used. The frequency of lubrication, adjustments to be made regularly, and recommended spare parts by the equipment/machine/instrument manufacturer/supplier shall be carried out and appropriate inventory shall be held in store.

6.0 Taking over Certificate for Operation and Maintenance

On completion of the Operation and Maintenance services of the Contractor, as certified by the O & M line agency's representative, the Contractor will hand over the Works and the Site back to the JE/ AE. The JE/AE shall take over back the works and the facilities and issue a certificate accordingly.

Article 1: Commitment of the Principal/Owner

- 1) The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
 - (a) No employee of the Principal/Owner, personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
 - (b) The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Principal/Owner will, in particular, before and during the Tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the Tender process or the Contract execution.
 - (c) The Principal/Owner shall endeavour to exclude from the Tender process any person, whose conduct in the past has been of biased nature.
- 2) If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

Article 2: Commitment of the Bidder(s)/Contractor(s)

- 1) It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of fraud or corruption or Coercion or Collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2) The Bidder(s)/Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:
 - a) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal/Owner’s employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in

This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process.
 - c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/Contract(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
 - d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the names and addresses of agents/representatives in India, if any. Similarly Bidder(s)/Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.
 - e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
- 3) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
 - 4) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practice means a willful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.
 - 5) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or

Article 3: Consequences of Breach

Without prejudice to any rights that may be available to the Principal/Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder/ Contractor accepts and undertakes to respect and uphold the Principal/Owner’s absolute right:

- 1) If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. Such exclusion may be forever or for a limited period as decided by the Principal/Owner.
- 2) Forfeiture of EMD/Performance Guarantee/Security Deposit: If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Contractor.
- 3) Criminal Liability: If the Principal/Owner obtains knowledge of conduct of a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of IPC Act, or if the Principal/Owner has substantive suspicion in this regard, the Principal/Owner will inform the same to law enforcing agencies for further investigation.
