The emphasis of the course is on the contract management. Initially, the course introduces brief process of execution of works and procurement of materials through contracts with emphasis on different modes of execution, types of bids, parties for the contract and the required ethics. Subsequently the course delves into the applicable laws and their judicious use in the preparation of bid documents. The bid evaluation process and contracting process will be explained. The key aspects of contract management will be explained with emphasis on change requests and extension of contracts based on delay analysis. Then the course delves into Dispute resolution process and the importance of avoiding disputes and administrative measures to be taken to avoid the disputes. Case studies related to Contract Management and Arbitration will be presented for the better application of the applicable laws and contract conditions.
