The primary purpose of this Agreement is to institute an exchange of student/(s) that will provide student participant/(s) with an opportunity to study and benefit from the academic and cultural environment of the other institute.

The Student commits himself/herself to work at the University and at IITK on subject mentioned (Research Area) in Annexure A to this Agreement.

2. General rights and duties of involved institutes:

The University provides the funding for the Ph. D scholarship and all related fees. The University is responsible for stay of the Student in _____ (country) and booking of the airline ticket.

The Student accepts the Ph. D. scholarship and is committed to continue to work on his/her Ph. D. research.

The Student accepts to:

- work full time on the Ph.D research project;
- work under the supervision of both _____ and the local supervisor;
- report regularly to the University as stipulated in this agreement.

Both the Institutes accept that the Ph.D research of the Student will be partly conducted at its premises.

Both supervisors accept to supervise the Ph.D research of the Student during the entire Ph.D period. There should be a regular consultation between both the supervisors.

6. Premature termination of the scholarship

By the Student: The Student can prematurely terminate the research project in writing of the intention and reason to do so.

Due to project related reason: When it can be demonstrated by the Student that the scientific or technical research objective proved not to be feasible, or when insufficient results can be obtained for a full-fledged doctoral thesis. The University will contact the supervisors in order to verify the reasonableness of the Student's arguments and to determine the final date of the scholarship.

7. Reporting of scientific results

The Student has to submit a progress report on his/her activities accompanied by an evaluation report by both the supervisors (please specify whether quarterly/half yearly/yearly)

8. Intellectual Property Rights

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this agreement shall be owned (solely by IITK/jointly by the institutes to this agreement). The institutes shall have the right to determine the commercial exploitation and disposition of such intellectual property, and both institutes shall make joint applications for the registration of the same.

Any publication/thesis regarding results arising out of research area, intellectual property/ shall be possible with prior written consent of both institutes, such consent not to be unreasonably withheld.

IITK shall be free to use the results arising out of research area for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other party.

9. Coordination

_____ Supervisor and Local Supervisor will periodically review the progress of the research.

10. Confidential Information:

IITK does not absolve any confidential information during the research activity.

11. Dispute Resolution

Should there be a dispute relating to any aspect of academic cooperation, the Director, IITK and _____ will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility. If such a settlement cannot be reached, the dispute will be settled in the courts of New Delhi (India).

IITK and the University welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above.
