Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Following changes in BID No. <u>GEM/2025/B/6254894</u> date 21.05.2025, in Technical & T&C are updated with the existing tender,

1- Sample Clause

After award of contract – Successful Bidder shall have to get advance sample approved from buyer before bulk manufacturing / starting bulk supplies. Successful Bidder shall submit

Samples for Buyer's approval, within 7 days of award of contract. Buyer shall, as per contract spe cifications framework, either approve the advance sample or will provide complete list of modification required in the sample within 7 days of receipt of advance sample. Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller.

Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the contractor is required to submit an advance s ample, any expenses incurred by the contractor on or in connection with the production of stores in bulk, before the sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation in the event of such sample being found unacceptable by the B uyer / Consignee.

- 2- Authentic Lab Test Reports which justify the technical parameters from OEM.
- **3-** Only FSC and ISO-certified paper will be accepted.
- 4- Seller must declare Mass of 500 sheets including wrapping paper, in Kg/Ream: 2.49 kilogram (Minm.

- **5-** The supplier shall ensure that the items offered strictly conform to the technical specifications stated in the purchase order/tender document. Any attempt to quote products that comply only superficially or on paper, but do not match the actual required quality, standards, or specifications, shall be treated as misre presentation and may result in:
- Immediate rejection of the supplied items,
- Cancellation of the purchase order without any liability to the purchaser.
- Forfeiture of security deposit or EMD (if applicable).
- Debarment from future purchases for a period as determined by the purchaser.

The purchaser reserves the right to conduct random or detailed inspections, including physical testing of t he supplied goods, to verify compliance. Any deviation from the declared specification or attempt to pass off inferior quality as compliant shall be considered a breach of contract.

All the Bidders (Participated/Participating) are requested to update with changes accordingly.

Terms and Conditions (As per GeM)

1. General Terms and Conditions-

- 1.1 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Condit ions (GTC) as available on the GeM portal (unless otherwise superseded by Goods / Servic es specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable
- 1.2 Terms of delivery: Free Delivery at Site including loading/unloading. In respect of items requiring installation and / or commissioning and other services in the scope of supply (as i ndicated in respective product category specification / STC / ATC), and the cost of the sam e is also included in the Contract price.
- 1.2.1 Contracted goods should be delivered at the consignee or designated delivery locati on as per the working time of the buying organisation. Seller may get the same confirmed f rom consignee before scheduling delivery.
- 1.2.2 A copy of the contract should be available with the messenger / dispatching agency t hat delivers the Goods at consignee / delivery location (preferably pasted / attached outsid e the consignment / package) for easy reference and ease in delivery acceptance.
- 1.3 Delivery period: The Delivery Period/Time shall be essence of the Contract and delivery must be completed not later than such date(s). Any modification thereto shall be mutually agreed and incorporated in the Contract as per the provisions of the GTC.
- 1.4 Performance Security: If the Seller fails or neglects to observe or perform any of his obligations under the contract it shall be lawful for the Buyer to forfeit either in whole or in part, the Performance Security furnished by the Seller.
- 1.5 Taxes and Duties: Contract Prices are all inclusive i.e. including all taxes, duties, local I evies / transportation / loading-unloading charges etc. Break up of GST shall be indicated b

y the Seller while raising invoice / bill on GeM. While submitting the bill / invoice Seller shall undertake that the Goods and Services Tax (GST) charged on this bill is not more than what is payable under the provision on the relevant Act or the Rules made there under and that the Goods on which GST has been charged have not been exempted under the GST Act or the Rules made there under and the charges on account of GST on these goods are correct under the provision of that Act or the rules made there under.

- 1.6 Octroi Duty and / or other local taxes: Contract Prices are all inclusive hence no reimbu rsement over and above the contract price(s) shall be allowed to seller towards payment of local taxes (such as levy of town duty, Octroi Duty, Terminal Tax and other levies of local b odies etc).
- 1.7 Limitation of Liability: The provisions of limitation of liability between Buyer and Seller as given in the GTC shall be applicable here.
- 1.8 Resolution of disputes: The provisions of DISPUTE RESOLUTION BETWEEN BUYER AND SELLER as given in the GTC shall be applicable here.
- 1.9 Liquidated Damages: If the Seller fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeu re conditions aforesaid, @ 0.5% per week or part of the week of delayed period as pre-esti mated damages not exceeding 10% of the contract value without any controversy/dispute of any sort whatsoever. In case, Service Level Agreement (SLA) is applicable the same shall be applicable for the Contract.
- 1.10 Financial Certificate:
- 1.10.1 The expenditure involved for this purpose has received the Sanction of the compete nt financial authority.
- 1.10.2 The funds are available under the proper head in the sanction budget allotment for the concern financial year.
- 1.10.3 I have been fully authorized by the department to sign the supply order or incur the liability of the Goods being ordered.
- 1.11 The bidder should submit a self declaration to the effect in bidder's official letter head that their agency have not been black listed by any Agency whatsoever till date.
- 2. Buyer Added Bid Specific Terms And Conditions-
- 2.1 Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.
- 2.2 Bidders shall quote only those products in the bid which are not obsolete in the market and has at least 2 years residual market life i.e. the offered product shall not be declared e nd-of-life by the OEM before this period.
- 2.3 Bidders are advised to check applicable GST on their own before quoting. Buyer will no t take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
- 2.4 End User Certificate: Wherever Bidders are insisting for End User Certificate from the B uyer, same shall be provided in Buyer?s standard format only.
- 2.5 Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid d ocuments. Buyers can match and verify the Data Sheet with the product specifications offe red. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

- 2.7 Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
- 2.8 Upload Manufacturer authorization: Wherever Authorised Distributors are submitting the bid, Manufacturers Authorisation Form (MAF)/Certificate with OEM details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.
- 2.9 Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods
- 2.10 OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. In case of bunch bids, the OEM of CATEGORY RELATED TO primary product having highest bid value should meet this criterion.
- 2.11 IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The c ertificate to this effect should be submitted.
- 2.12 Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Funct ional Service Centre.
- 2.13 Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have De dicated/toll Free Telephone No. for Service Support.
- 2.14 Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.
- 2.15 Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
- 2.16 To be eligible for award of contract, Bidder / OEM must possess following Certificates / Test Reports on the date of bid opening (to be uploaded with bid): OEM or OEM Authoriza tion.
- 2.17 Warranty period of the supplied products shall be as given in specifications from the d ate of final acceptance of goods or after completion of installation, commissioning & testin g of goods (if included in the scope of supply), at consignee location. OEM Warranty certific ates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarante e period. Seller should have well established Installation, Commissioning, Training, Trouble shooting and Maintenance Service group in INDIA for attending the after sales service. Det ails of Service Centres near consignee destinations are to be uploaded along with the bid.
- 2.18 NET WORTH: Net Worth of the OEM should be positive as per the last audited financia I statement.

20. Past Project Experience

For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:

- a. Purchase Order copy along with Invoice(s) with self-certification by the bidder that suppl ies against the invoices have been executed.
- b. Execution certificate by client with order value.
- c. Any other document in support of order execution like Third Party Inspection release not e, etc.

21. Past Project Experience

The Bidder / OEM {themselves or through reseller(s)}, should have executed project for su pply and installation / commissioning of same or similar Category Products during preceding 3 financial years (i.e.current year and three previous financial years) as on opening of bid, as per following criteria:

- (i) Single order of at least 35% of estimated bid value; or
- (ii) Two orders of at least 20% each of estimated bid value; or
- (iii) Three orders of at least 15% each of estimated bid value.

Satisfactory Performance certificate issued by respective Buyer Organization for the above Orders should.

be uploaded with bid. In case of bunch bids, the Category related to primary product havin g highest bid value should meet this criterion.

- 02 Copy/Paste of Our Required Technical Specifications or any non-relevant document provided in Technical BID from bidders may leads to rejection of BID.

If the bidder is an OEM, then self-declaration on company letter head is to be submitted by the bidder.

Bidders participating as Class-I Local Supplier (Minimum Local Content 50% or above) mus t submit the local content declaration/certificate issued from OEM only. Otherwise, Bidder would be treated as Class II Local Supplier.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
