Dear SPGC Chair.

In the 1st SPGC meeting held on 28th October 2025, it was suggested that MSc course numbers be revised in alignment with the PG program numbering system (as per the minutes attached). Currently, several courses in the MSc Mathematics template are numbered in the 2XX range. In response, the department has initiated the process of renumbering these courses to the 4XX series or higher.

As part of this process, the department proposes the following changes to the MSc Mathematics program template:

- Renumbering without Syllabus Change:
 The courses MTH308, MTH304, and MTH305 will be renumbered as MTH4XX series courses, with no changes in content.
- Renumbering with Minor Syllabus Change:
 The course MTH202 will be renumbered to MTH4XX, with syllabus modifications affecting less than 20% of the course content. The revised syllabus is attached.
- Dual Course Version for MTH301:
 The course MTH301 will be retained as part of the UG curriculum. A new version of this course, MTH4XX, is proposed for the MSc Mathematics program with less than 20% content modification. The updated syllabus for the MSc version is attached. We request that a new course number (in the MTH4XX series) be assigned to this modified version.

The revised MSc Mathematics program template, incorporating the above changes, is also attached.

Additionally, please note that the department had previously proposed two new courses:

- First Course in Linear Algebra
- First Course in Abstract Algebra

Both of these courses have already been approved and assigned the numbers MTH402 (First course in Linear Algebra) and MTH406 (First course in Abstract Algebra), respectively. Approval letters are attached for your reference. In the revised MSc template, MTH402 replaces MTH201, and MTH406 replaces MTH204.

We request the SPGC to kindly take the necessary steps to formalise these updates.

Annexure B

Proposal for summer registration of MSPD students to do research-work

With a view to facilitating MSPD students do research with prospective PhD-supervisors (and, hence, be eligible for financial assistance) during the summer terms before migration to PhD part of the program, following measures are proposed:

- 1) A 9 credit course (tentatively, PHY499) will be introduced. Grading scheme will be S/ X. Students should register for 18 credits worth of PHY499 in summer terms. DPGC convenor will be the instructor-in-charge and students will be allotted supervisors from the Department of Physics under whom they will do research-work. Cosupervisors from elsewhere are allowed.
- 2) Daily biometric attendance of students taking PHY499 is mandatory during the summer terms.
- 3) In special circumstances, if a student needs to do other courses (e.g., to clear backlogs) during summer term, then they may register for only 9 credits worth of PHY499 if DPGC allows.
- 4) The PHY499 course should reflect on the transcripts of the students; however, it is not required for completion of the degree.
