Sub: Revision of rates of PhD Scholarship

This has reference to above mentioned letters of MHRD and subsequent office orders issued by the Institute. Recently MHRD has issued a letter (no. MHRD/TS-1 F.No. 17-2/2014-TS-1 dated September 01, 2015), in which it is clarified that all research scholars (PhD students) will have a uniform duration of 5 years for payment of PhD fellowship (JRF/SRF) irrespective of whether they were B.Tech./M.Sc. degree holder or M.Tech. degree holder at the time of admission.


In view of the above referred MHRD letter of September 01, 2015, the revised rates of Teaching Assistantship / Scholarship for PhD students of the Institute are summarized below:

Sponsored and Self-Financed Category of students including those in receipt of any other similar assistantship/scholarship/fellowship will not be eligible for assistantship/scholarship/fellowship under the revised scheme.

Under special circumstances, if Institute is unable to provide accommodation to a PhD student and on the approval of DOSA he/she is allowed to stay outside the campus, he/she will be eligible for HRA as per the Central Government norms.
