**#3.**

**Exchange of Students and Scientists**

Within the framework of this agreement, students and scientists of both parties should have the opportunity to visit the partner institution while carrying out research programs, third party projects and dissemination of the created knowledge.

Each institution is free for the selection of students and researchers to be exchanged.

**#4.**

**Authorized Representatives for Implementing the Collaboration**

A working group comprising of representatives of both parties shall be responsible for the implementation of the obligations laid out in this agreement.

A representative from the participating agency.

Mr \*\*\*\*\* will be the representatives from POWER, IIT Kanpur.

The representatives will meet periodically and find ways to strengthen the cooperation between the two institutions.

**#5.**

**Particulars of Finances**

Visits by IITK students or scientists or experts/scientists to any working site of **ABC/POWER** will be funded by PoWER, IIT Kanpur and ABC jointly. Visits of experts from both the parties for any third party project/research carried out inside or outside IITK will be funded according to the agreements with the third party. The host party is expected to provide basic arrangements of accommodation for exchange of students and experts.

Both the parties will waive basic tuition/registration fees for workshops, conferences or short duration courses hosted by them as partners.

All exchange students and scientists will abide by the rules and regulations of the host institute.

The number of students or scientists exchanged will be case-specific and will be decided mutually.

**#6.**

**Insurance, Medical and Safety Cover**

The exchange students/scientists are recommended to have an insurance/medical/safety insurance of their own institutes and the host institute will not be responsible for that.

In the case of a third party project, it will be decided at the time of the agreement.

**#7.**

**Liabilities and Disputes**

The contracting parties are not liable for damages or violation of contract.

In case of a dispute, Faculty Advisor, PoWER, IIT Kanpur and DEF of ABC will jointly solve the dispute in a spirit of independence with a sense of mutual respect, and shared responsibility.

**#8.**

**Commencement and Duration of the Agreement**

The agreement will come into force the day it is signed by the two parties.

The agreement is valid for duration of n years.

Information and data that will be exchanged between the two parties will be treated as confidential only when either of the party claims it to be confidential. All other data and information will not be treated as confidential and can be brought to public domain for dissemination purposes.

**#10.**

**Intellectual Property Rights**

Rights in terms of patent or copyright law that are not exclusively worked out by one party shall be vested to both institutes in this agreement. The portion of the rights depends on the significance of the workload and provided resources that led to the results.

The design of specific agreements for use, commercialization and revenue sharing will be taken care jointly by both parties when such a case arises.

Publications will be made jointly after the mutual agreement between both the parties.

Agreement must not be withheld unreasonably.

**#11.**

**Final Provisions**

This agreement is drafted in English.

Cooperation with other institutions remains unaffected through this agreement.

Any supplement or amendment will be done on mutual consensus. It will be written down for a legal existence.

The duration of the agreement can be changed by a mutual consensus.
