Selection Criteria:

1. The firm should have valid GST Registration, PAN the same should be submitted along with the bid.
2. Firm should have excellent goodwill and name-fame in the town/district/state.
3. Firm should have minimum 05 (Five) years' experience of providing and fixing of modular Fabric Structure.
4. Firm should have completed at least 3 similar orders for providing & fixing of modular fabric structures to covering like cafeteria, sports area, car parking resort tents open terrace.
5. Firm should have an average turnover of at least Rs.10 Lacs during the last five years.
