Request for Proposal

Quotations are invited from reputed advertisement firms for publishing the JEE (Advanced) - 2018 examination advertisement in the newspapers listed in the ANNEXURE. Proposals must be submitted, in a sealed envelope, so as to reach JEE Office, IIT Kanpur, Academic Affairs Building, Kanpur-208016, **not later than 15:00 hrs, November 14, 2017**. Late tenders shall not be accepted, under any circumstances.

The bid document has to be submitted along with a tender fee of *INR 1,050 (One thousands) only in the form of demand draft in favor of **JEE, IIT KANPUR**. There is no exemption from payment of tender document fees and tenders without requisite fees. The exemptions for registered MSEs shall be available as per the latest government notification. The bidders registered as MSEs shall have to submit a duly certified copy of their registration with the registering authority and copy of the latest notification for the sought Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with the Central Purchase Organisation or the Concerned Ministry or Department.

The rate of Taxes and the percentage of such other taxes legally leviable and intended to be claimed should be distinctly shown along with the price quoted. Where this is not done, no claim for Taxes will be admitted at any stage and on any ground whatsoever.

Essential Qualifications of the Bidder

1. The company should have annual turnover of at least 10 crores over the last three financial years (proof to be submitted).
2. The company should have done at least 3 similar assignments for IITs/IIMs/other GFTIs (proof to be submitted).

Bidder who does not meet the above essential qualification, will be declared ineligible.

Award of Tender

Tender will be awarded to the eligible (as per the essential qualification mentioned above) Bidder with the lowest quotation.

Notification of Award of Tender and Performance Bank Guarantee

The notification of award will constitute the formation of the contract and shall be binding on both the parties. Upon the selected successful bidder's furnishing of Performance Bank Guarantee, IITK will notify each unsuccessful bidder and return their EMD. The EMD of successful bidder shall be returned only after furnishing of Performance Bank Guarantee and signing of Contract.

IITK will require the successful bidder to provide an irrevocable, unconditional Performance Bank Guarantee within 5 days from signing of the agreement post Notification of award, for a value equivalent to 10% of the total cost. The Performance Guarantee should be valid for a period of 3 months. The Performance Guarantee shall be kept valid till completion of the project. The Performance Guarantee shall contain a claim period of three months from the last date of validity. The successful bidder shall be responsible for extending the validity date and claim period of the Performance Guarantee as and when it is due on account of non-completion of the project. In case the successful bidder fails to submit performance guarantee within the time stipulated, IITK at its discretion may cancel the order placed on the successful bidder without giving any notice. IITK shall invoke the performance guarantee in case the successful Vendor fails to discharge their contractual obligations during the period or IITK incurs any loss due to Vendor's negligence in carrying out the project implementation as per the agreed terms & conditions.

Mode of Payment

The payment shall be made in Indian Rupees and shall be paid only after successful completion of work without error and delays. In case the bidder fails to execute the contract, IITK shall have liberty to get the work done through any other agency with full cost recoverable from the bidder in addition to damages and penalty.

Dispute Resolution

All disputes arising with respect to the bid document shall be subject to the jurisdiction of appropriate court of Kanpur, Uttar Pradesh, India, alone and shall be governed by the law of India. IITK reserves right to award the work/cancel the award without assigning any reason. In case of differences with regard to the bid document, if any, the decision of IITK shall be final.

Bidders are neither allowed to join hands with other firms to participate in the tender nor allowed to submit multiple bids. Any such act will make the bid liable for rejection. Bidders giving false information, submitting forged document(s) or involved in any other fraudulent practice will make the bidder liable for rejection.
