### Amendment: Tender Notice for Grid tied Solar Inverter for 9KWp Solar Power Plant

- 3. The firm should be registered with Sales Tax Office and should have Service Tax Registration, Tax Payer Identification No (TIN) and PAN allotted to them. The firm must maintain an office/shop/show room registered in its own name, in the market/industrial area or another suitable place and should have a bank account wherein the payments may be sent directly in the bank. Supplier must print CST/UPTT/TIN No. on their Letter Head/Bill/Quotations.

- 5. Last date of receipt of Quotation is extended to 23 Dec 2014, 1500 hrs.
