## 1. MSWC elections:

3. Agenda related to "having an additional representative from old/new SBRA"

Proposed by SwatantraPratap Singh seconded by Pawan Kumar Nagar

Since the old and new SBRA are not in single premises, it is often felt that the problems felt by the residents are not identical to each other. The Convener, SBRA if being elected from old SBRA, the difficulties faced by the other facet of the residents is not being put forth appropriately. Though ideally the block representatives were supposed to serve this purpose, it has been observed in the recent past that their positions have become redundant. In addition, since the block representatives are restrained only with respect to their block related menial issues rather than the global problems faced by the residents in the premises. Hence, the MSWC unanimously accepted to have an additional representative from old SBRA if the elected Convener is from new SBRA and vice-versa in order to cater the needs of the residents as well as to bring it to the notice of MSWC. Further this action plan would facilitate the Convener to work more efficiently considering the recent increase in the number of residents under the student's SBRA.But as per the 4.1.1 and 4.1.4, in order to make any changes in the constitution ie., constitution amendment has to be done for creating the new post, for which GBM is to be called to finalize the same. Since the elections for the next term has been initiated, the issue would be addressed by the new committee.
