## 1. Ratification of minutes of MSWC meeting held on 19th March 2015

## 2. Completion of MSWC committee

#### 3. Request for changing SBRA Apartment by Deepak yadav (J-1)

In reply to a mail from Warden, IWD seeks to solve the problem of seepage by removing existing brick tiling and laying brick koba. The maintenance in the occupied quarter can create disturbance to the resident, so an alternate arrangement for their stay has to be made. Considering the medical urgency of his wife, committee decided that he can be permanently shifted to the next vacant house in old SBRA (A rule was made that old SBRA resident will be shifted to old SBRA only). In case he is unable to shift to the first vacant house, he can opt for the next one in old SBRA.

### 5. Formation of special committee for housewives.

## 6. Maintenance of water purifiers in both old and new SBRA

Maintenance of water purifiers in old SBRA (RO and Aqua) and new SBRA (Aqua, AA block) will be done.

## 7. Amendment in guest room rules

The guest will be asked for ID cards from now on. Updated guest room form will be uploaded on website.

## 8. Shubhash's (sweeper) salary should be paid to his account only

The salary of the temporary employee is not feasible to pay to his account unlike permanent employees.

## 9. Issue related to eligibility of Mr. Srinivasan (M-4) and Mr. Chandan Sarangi (Z-19) as MSWC

Mr. Karthik Balasundaram and Mr. Srinivasan had raised their concern regarding violation of clause 2.1.3 of SBRA constitution while nominating Mr. Chandan Sarangi (while Pavan Nagar was already an elected member (Z-13 to Z-24), why was Mr. Chandan Sarangi nominated). Similarly Mrs. Sinnu Thomas, Mr. Chetan Patel, Mr. Rahul Soni and Mr. Chandan Sarangi raised concern that why was nomination for M block was asked during elections (M block has only 4 houses which violates clause 2.1.3 of the constitution). As there were many cases in the past, a decision was taken that for the welfare of SBRA more than one member can be in the committee from the same block. Keeping in mind that both members are dynamic personalities and are eager to work for the betterment of SBRA both members will stay in the committee. It was also decided that from next year 1 nomination for combined A-B and M block will be asked for election of block representative.

#### 10. Dumping of waste slider in old SBRA Jhula park

The waste slider in old SBRA Jhula park will be disposed in proper manner.

## 11. Car washing in old SBRA

The Proposal of making place for car/two wheeler washing on some site of green area of SBRA with arrangement for ground water replenishment with water used for washing was unanimously accepted.
