The following issues discussed in MSWC Meeting held on 24th April 2025, 8:00 PM:

1. Parking Management

- Abandoned cycles/vehicles will be identified and removed from the SBRA premises.
- Residents are advised to park their vehicles in an orderly and designated manner.
- Parking slots will be equitably demarcated for each house in the old SBRA parking zone.
- A parking area banner will be installed to guide residents and visitors.

2. Installation of A-L Plate beneath the SBRA Signboard (Old Gate)

- Unanimously approved by all members.

3. Installation of Focus Lighting for SBRA Signage (Old Gate)

- Unanimously approved by all members.

4. Development of Jhula Park – Grass Laying Initiative

- Unanimously approved by all members to lay green grass in the park area.

5. Addressing Unauthorized Occupancy

- The issue remains under deliberation. Further discussions and strategies will be considered in upcoming meetings.

6. Proposal for Guestroom Charge Revision

- Not recommended, as rates were revised recently in the previous year.

7. Proposal for Increasing Security Deposit

- Not recommended, considering the current financial surplus in SBRA accounts.

8. Maintenance of Water Coolers (Servicing & TDS Monitoring)

- Water coolers to be cleaned every three months.
- Monthly TDS level checks and adjustments to be ensured.
- Major servicing to be conducted annually.

9. Installation of CCTV Camera at SBRA Gate (Facing Inside)

- Unanimously approved by all members.
- A signboard indicating "Under Surveillance" will also be installed.

10. Preservation of Greenery – Plants and Pots

- Signage stating "DO NOT PLUCK / DAMAGE" will be installed to prevent misuse.

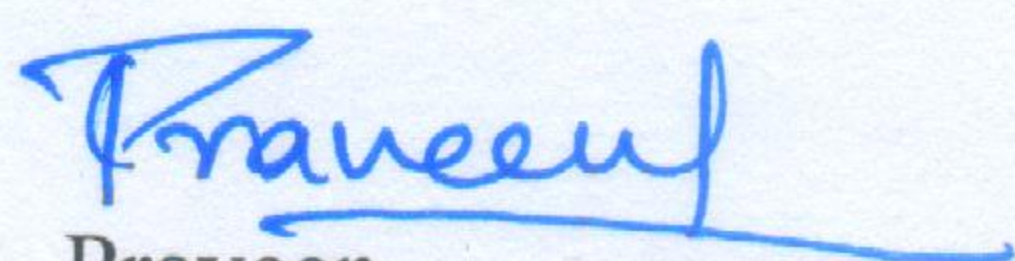
11. Regulation of Outsider Entry

12. Duration of Stay in SBRA Residences

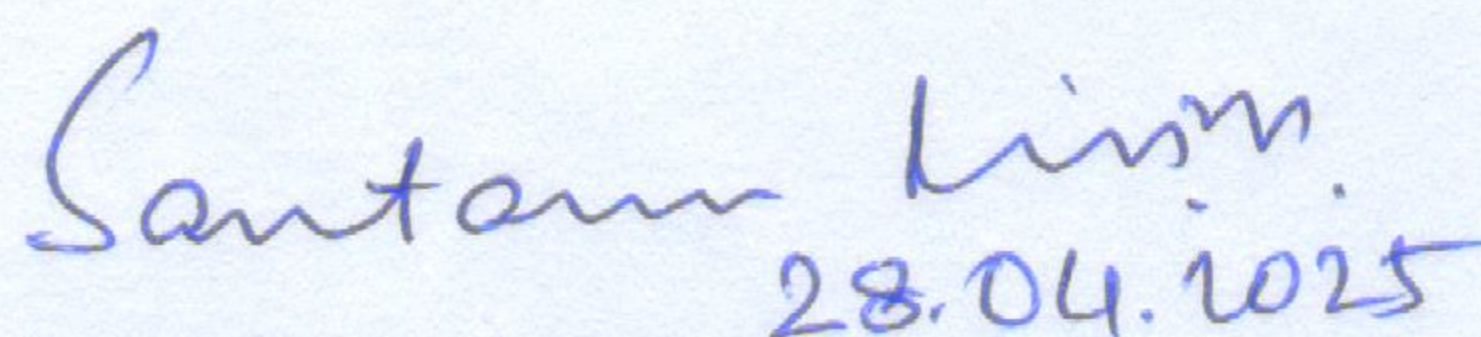
- Not recommended for GBM action by members, as this falls under the jurisdiction of the Institute.
