The following issues were discussed in MSWC meeting that was held on 15th April, 2016:

1. Ratification of minutes of MSWC meeting held on April 1st 2016

There were no corrections in draft minutes and minutes have been uploaded to website.

2. SBRA allotment issue of Mr. M Seetha Ramaiah

House I-2 was offered to Mr. M Seetha Ramaiah but he showed his unwillingness to bring his wife within 45 days of allotment due to some medical reasons, hence asked for relaxation. MSWC felt that before considering a candidate for such relaxation, first he or she must be the resident of SBRA and hence not given any relaxation to Mr. Ramaiah. Now it's up to Mr. Ramaiah whether he is willing to take this offer or not. However MSWC may think to consider Mr. Ramaiah's request once he is the resident of SBRA.

3. Possession of house M-2 and Cleaning issues at the back side of M-2

MSWC has decided to write an application through warden Sir for the possession of house M-2 officially. Instructions have been given to Subhash (sweeper) and gardener for the regular and proper cleaning at the back side of this house.

4. Issuing of sport items/equipments

MSWC felt that sports items are being utilized very less by the residents or kids. There are certain items which have never been issued by the residents. Keeping it in mind, sports secy along with the MSWC have come out with the rule and regulation for the better and maximum use of sports item/equipments by the residents.
