
Facebook page will be created for SBRA residents with MSWC members as moderators. This will enhance a healthy discussion among residents.


Mailing list of student's dependents can be collected to send mails regarding cultural, gardening and sports events.

4. **Providing seniority to “Mr. Rashid Zafar” based on SBRA constitution clause “7.2.7”:**
Mr. Rashid Zafar made the below argument:

{“I was a resident of B2, SBRA from May 2013 to April 2015. In 2015, I left SBRA and converted my PhD to part-time. But I did not take back my SBRA security deposit because there was a chance that I may be back to the campus to complete my PhD. In June 2018, I fully came back to IITK campus and applied for SBRA accommodation according to SBRA constitution clause 7.2.7 which is as follows.

7.2.7 If a student going on semester leave or for some other reason vacates the apartment on his own then he shall be given the apartment on first priority as and when he applies again for an apartment.”

But I was put in waiting list without any discussion in MSWC. Fortunately I was allotted doordarshan quota SBRA (T4) and I am residing in it. I believe that I should have been allotted SBRA in June 2018 on first priority. So I request you to consider me a regular SBRA resident and also consider my seniority from June 2018 for shifting purpose.”}

It was unanimously agreed that Mr. Rashid Zafar should have been kept in priority list instead of SBRA general waiting list. Since he has already got doordarshan quota SBRA (T4), at least his seniority for house change should be considered from June 2018 (date in which he came back to IITK as full time student).

5. **Fine waiver for Saurabh Srivastava:** Saurabh Srivastava couldn't vacate his house (Z-6) in a month after completion of his defence because of medical emergency to his father. Because of this, he also couldn't attend the convocation and submit his thesis. It was unanimously agreed that his fine amount of Rs.1500 can be waived off on humanitarian grounds after he submits medical proof (documents) in SBRA office.

6. **Issue with parking in OLD and NEW SBRA:** Some residents have allowed their hostel friends to park their car in SBRA premises. It was agreed that security office will be contacted immediately and steps will be taken against their SBRA counterpart.




NO parking signs on roads: No parking signs will be painted on roads based on the SBRA parking map, so that residents are aware about the parking areas.
